Important Notice

Attention: Candidates of CGL-2021 examination seeking exemption from appearing & qualifying in DEST

Skill test for CGLE, 2021 will be conducted by the Commission on 4th & 5th January, 2023. Relevant instructions pertaining to exemption from DEST or CPT are as follows :-

OH candidates opting for the post of Tax Assistant in CBDT are exempted from appearing in Skill Test, provided such candidates submit a Certificate in the prescribed format (Annexure-XVI) to the Commission from the competent Medical Authority, i.e., the Civil Surgeon of a Government Health Care Institution declaring him to be permanently unfit for the Typing Test because of a physical disability. OH candidates opting for post of Tax Assistant in CBEC and UDC/ SSA in Central Bureau of Narcotics are not exempted from Skill Test. All other PwD candidates are not eligible for exemption from the Skill Test.

OH Candidates who have qualified in Tier-III of CGL Exam, 2021 and who opted for exemption from appearing in Skill Test (DEST) for the post of Tax Assistant in CBDT, are required to send scanned copies of duly filled Annexure-XVI, Undertaking (mentioned as annexure) and their medical certificate from notified Medical Authority (as mentioned in Annexure-XVI of Notice of the examination) on email ID: sscnrskilltest@gmail.com, **latest by 30-12-2022.**

Alternatively, the candidates may also report at the venue for Skill Test (DEST) on the date of their Skill Test (DEST) along with aforementioned documents (original & photocopy) for seeking exemption from DEST only for Tax Assistant in CBDT.

No exemption from CPT is allowed for any category of PwD candidates. PwD candidates who are eligible for scribes as per para 7.1 and 7.2 of the Notice of Examination will be allowed additional compensatory time of 5 (five) minutes in CPT. Only those VH candidates who opt for scribes in the written examination will be provided passage reader at the time of CPT.

The candidates are required to produce all these documents in original before the Commission at the time of document verification. If any candidate fails to produce the same during document verification, Commission would cancel the candidature of such candidate for this exam and such candidates will have no claim against the Commission's decision.

All the concerned candidates of CGLE, 2021 are directed to go through Notice dated 23.12.2021 pertaining to CGLE, 2021 for further details.
