(ii) Two years experience as a Shift-in-charge /Dyer/ Bleacher/ Finisher/ Dyeing Master/ Printing Master/ Textile Processing Assistant/ Laboratory Technician/ Demonstrator (Processing)/ Supervisor, handling work relating to bleaching or dyeing or printing or finishing etc. in a textile processing factory/ processing or dye house/ dyeing laboratory/ handloom establishment.

OR

(i) Diploma in Handloom Technology or Diploma in Handloom and Textile Technology from a recognized University or Institute;

(ii) Post Diploma in Textile Chemistry of Textile Processing from a recognized University or Institute;

(iii) Two years experience as a Shift-in-charge /Dyer/ Bleacher/ Finisher/ Dyeing Master/ Printing Master/ Textile Processing Assistant/ Laboratory Technician/ Demonstrator (Processing)/ Supervisor, handling work relating to bleaching or dyeing or printing or finishing etc. in a textile processing factory/ processing or dye house/ dyeing laboratory/ handloom establishment.
